# GENERAL RELEASE AND WAIVER OF LIABILITY AGREEMENT

The undersigned Participant understands and acknowledges that it is a requirement as a condition of participation in Las Cruces Fun Hunt, to enter into this General Release and Waiver of Liability Agreement, and to assume all risks of participation in the Event by signing below.

The Participant on behalf of himself/herself and on behalf of the Participant's personal representatives, assigns, heirs, executors, and successors hereby fully and forever releases, waives, discharges and covenants not to sue Las Cruces Event Planning, its parent and affiliated corporations and charities, its officers, directors, shareholders, employees, contractors, or anybody else acting on behalf of Las Cruces Event Planning, any and all municipal agencies whose property and/or personnel are used or in any way assist, all sponsoring or co-sponsoring companies or individuals related to the Event, together with their officers, directors, shareholders, successors and assigns, (collectively "Releasees") from any and all liability to the Participants and his/her personal representatives, assigns, heirs, executors, and successors for any and all loss(es), damage(s) and any and all claims or demands therefore, on account of injury to the Participant, his/her property or resultant death, whether caused by the active or passive negligence of all or any of the Releasees or otherwise, in connection with the Participant 's participation in the Event.

The Participant acknowledges that they are responsible for any damages done to property, by the Participant, during the Event. Las Cruces Event Planning will not be held liable for any repairs or money due from the result of property damage.

The Participant acknowledges that the entry fee paid is non-refundable and non-transferable. The Participant acknowledges and agrees that Las Cruces Event Planning, in its sole discretion, may delay or cancel the Event for any reason.
